Following on our article regarding the Department of Health's recent ban on cannabis- and hemp-infused food products, as published earlier today, President Cyril Ramaphosa has now intervened to withdraw the ban following widespreadbacklash.

The ripple effects of South Africa's cannabis food ban: Implications for agriculture and beyond

On 28 May 2024, the President signed the Cannabis for Private Purposes Act 7 of 2024 (Cannabis Act) into law. The Cannabis Act establishes a legal framework for the private use, possession and cultivation of cannabis in South Africa. However, the act still imposes significant restrictions on the legal cultivation and commercial trade of cannabis. Conversely, hemp, as defined below, has been extensively cultivated for commercial purposes in South Africa and other African countries for several years now. However, recent changes to South Africa's cannabis and hemp regulatory framework have caused much controversy in the agricultural sector.

Categorisation of property by municipalities of developer stock vacant land

In the recent case of City of Tshwane Metropolitan Municipality and Others v Copperleaf Country Estate (Pty) Ltd and Another (245/2023) ZASCA 69 (3 May 2024), the Supreme Court of Appeal (SCA) upheld a judgment granted by the Gauteng Division of the High Court, Pretoria, concerning the City of Tshwane Metropolitan Municipality's (City) supplementary valuation rolls for 2010–2011 and 2013–2017. The cross appeal filed by Copperleaf Country Estate (Pty) Ltd (Copperleaf), challenged the incorrect categorisation of its properties as "vacant land" rather than "business/commercial".

Overview of the (r)evolution of legislation governing the use of cannabis: Where to from here?

Cannabis has been a hot topic in the media and bold statements have been made by the Government regarding the economic potential that the cannabis sector can unlock in the country. President Cyril Ramaphosa has referred to the potential revenue that could be created in the sector on two separate occasions during his annual State of the Nation Address. It has also been highlighted that industrial hemp and cannabis will create a pathway to industrialisation by having a ripple effect through to various other sectors such as foreign investment, agriculture, employment and construction. Although the Government's stated intention to relax and review policies that hinder the growth of the industry is appreciated, South Africa is at a crossroads when it comes to competing with international cannabis industries developed within a regulatory framework.
