#### The decriminalisation of cannabis use and/or possession for minors: A significant shift in South African drug law reform

In 2019, the Constitutional Court in Minister of Justice and Constitutional Development and Others v Prince and Others (1) SA 14 (CC), partially confirmed the judgment in Prince v Minister of Justice and Others (4) SA 299 (WCC), which declared provisions of the Drugs and Drug Trafficking Act 140 of 1992 (Drugs Act) and the Medicines and Related Substances Act 101 of 1965 unconstitutional. In doing so, the Constitutional Court decriminalised the use, possession and cultivation of cannabis by adults for their personal use in private.

#### Developments in anti-bullying measures in South Africa: Possible jail time for bullies

South Africa is a country plagued by bullying and associated child-on-child abuse. Despite there being five separate pieces of legislation aimed at preventing and addressing bullying among minors in and outside of school, educational institutions, parents, and teachers are still struggling to grapple with the complex nature of bullying. Over the past few months, our country has had a notable increase in minor student suicides, which have been heavily reported to be a consequence of bullying.
