[Big boost for a South African green hydrogen economy as new tools released](#)

On 17 February 2025 two key environmental planning tools were published with the aim of guiding and supporting the responsible development of green hydrogen projects which will play an important role in South Africa's commitment to achieving a Just Energy Transition by replacing the use of fossil fuels in the fertilizer industry and in other hard-to-abate industries such as the heavy mobility, steel and cement industries.

[Eskom clarifies the issue of "curtailment" for IPPs](#)

In January 2024 Eskom published the much-anticipated addendum to the Generation Connection Capacity Assessment (GCCA) (Addendum). The Addendum was first mooted in the GCCA 2025 published in October 2023 (GCCA 2025). It is intended to provide clarity in respect of Eskom's proposal in the GCCA 2025 to use "curtailment" to address the challenges of limited available grid capacity faced by independent power producer (IPP) projects in the Eastern, Western and Northern Cape (the provinces).
