PLANNING FOR PUBLIC HOLIDAYS AND EXTRA PUBLIC HOLIDAYS IN 2012

The 16th of December 2012 is the only public holiday that falls on a Sunday. In terms of the Public Holidays Act, Monday 17 December 2012 becomes an additional public holiday. The extra day off, in addition to the existing public holiday, impacts on working arrangements and shifts and needs to be considered in advance by employers. Collective agreements may govern public holidays, working arrangements and shifts.

Employers can expect requests for additional days off on Monday, 30 April 2012, Friday, 10 August 2012, Monday, 24 December 2012 and Monday, 31 December 2012. Employers may wish to timeously make arrangements with employees to work in the additional days.
